

The National GEM Consortium Announces the Appointment of Tim Archer as Chairman of the Board

Archer succeeds Michael Greene, who served as chairman since 2018.

"I have seen first-hand the energy and dedication that GEM fellows and interns have brought to Lam. Partnering with GEM is about opening doors for the next generation, while advancing innovation within the semiconductor and technology industries."

"Under the leadership of Michael Greene, GEM has been able to make significant strides and we are forever grateful to Michael for that. There is, however, no intention to slow down as an organization, and I can think of nobody better to help us shift into an even higher gear than Tim Archer.
